How to give to the Wells County Public Library Memorials & Gifts

A monetary gift may be given **directly to the library** to purchase equipment or library materials that benefit library patrons. The contributor may request that the gift be placed into a *Restricted Fund* (used for a specified purpose) or may choose the *Unrestricted Fund* (allow the library to decide how the gift is best utilized). Examples of prior donations to Memorials & Gifts include book purchases, the map rack in the Indiana Room, a digital piano, art, and an automatic entrance door. All **gifts are tax deductible**.
